WorkSafe ACT publications fall into one of three categories:

- Handbooks - these are booklets running to several pages or more on a given topic. While these books may refer to the superceded 2008 legislation their content is still relevant except where they directly refer to sections of the older legislation.
- Guidance Notes - these are brief outlines of the pertinent points in relation to any given matter, commonly only 2 or so pages though occasionally slightly longer.
- Safety Alerts - this is an urgent, short communication that describes a work practice, incident or item that the regulator believes presents an immediate risk and requires corrective action. A Safety Alert provides background information, contributing factors and outlines controls (in preferential order if there is more than one option) which the regulator has identified as practical measures that may assist eliminate or reduce the risk.
